INSTRUCTIONS TO CONSULS & SHIPPING MASTERS

This report is intended for use only for Births & Deaths which occur in a non-UK registered ship. The Master of a foreign ship can only be required to make a Return of Birth or Death if they call at the United Kingdom (in which case a form RBD1 is used).

At ports abroad a Proper Officer may receive information that a citizen of the United Kingdom or Colonies ** has been born or has died on a foreign ship which has arrived within his district and which is not proceeding to the United Kingdom. In such cases they should endeavour to get the Master of the ship to complete this form which will form the basis of registration of the Birth or Death. It is most unlikely that a Master of a foreign ship will have a supply of these forms and the Proper Officer should therefore provide it from their own stock.

It is not essential in these cases for the report to be made by the Master of the ship but it is desirable that they should do so. If the Master is unable to complete the form then it should be completed by another reliable person having the knowledge of the facts. If all the facts are not known, as many of them as are known should be recorded herein.

The Proper Officer should be satisfied that the vessel is a sea-going ship.

- * In the ship includes: in a ship's boat of ship's life-raft; being lost from a ship includes: a ship's boat or ship's life-raft.
- ** Citizen of the United Kingdom or Colonies under the British Nationality Act 1981 means a British Citizen, British Dependent Territories Citizen, Overseas Citizen or under the Hong Kong (British Nationality) Order 1986, a British National (Overseas).
