STOWAWAYS INCIDENT REPORT

We are required by IMO Circular FAL.2/Circ.50/Rev.3 to submit via the IMO GISIS database, details of stowaway incidents. Having due regard for the Merchant Shipping Act 1976 Sections 142, which makes it illegal to secrete stowaways on Bahamas ships.

A stowaway is defined as a person who is secreted on a ship or in cargo which is subsequently loaded on the ship, without the consent of the shipowner or the master or any other responsible person, and who is detected on board the ship after it has departed from a port, or in the cargo while unloading it in the port of arrival, and is reported as a stowaway by the master to the appropriate authorities.

This form will assist the BMA in fulfilling its statutory obligations.
