The Bahamas' Register has a broad-based portfolio of ship types and an in-depth understanding of their particular needs.

While perhaps best known for its world-class cruise fleet, passenger ships make up just 11% of ship numbers on The Bahamas Register. General cargo accounts for 15%, tankers 19% and bulk carriers 16%. The Bahamas is also proud of its technical expertise in supporting the offshore industry – offshore oil and gas support vessels alone account for 17% of the vessels registered with the Flag.

Seafarers & Manning

Ensuring the highest standards for seafarers

Ships and units registered with The Bahamas are required to comply with both international and national regulations, ensuring they are sufficiently and efficiently manned with appropriately trained personnel. The BMA also mandates full compliance with the Maritime Labour Convention (MLC) 2006, which establishes seafarers' rights to fair and decent working conditions.

The Seafarers and Manning Department ensures that all seafarers aboard Bahamian vessels are trained and certified in line with the International Convention on Standards of Training, Certification, and Watchkeeping (STCW). The department also conducts STCW Deck & Engineering Certificate of Competency (CoC) exams, both written and oral, in The Bahamas.



Inspections & Surveys

Committed to maximising fleet performance

Safety of life, maritime security, and marine environmental protection are at the core of The BMA's work.

The Inspections & Surveys Department ensures all registered ships meet international and national regulations, reviewing vessels for technical suitability and overseeing The BMA's annual inspection programme, Port State Control, Recognised Organisations, and quality control. The department also sets technical standards and approves Bahamas-approved LSA service providers (BASP).

As part of the registration requirements, the technical suitability and age of a vessel are also taken into consideration before it is accepted to fly The Bahamas Flag.
